



### MR. BABAJIDE OLUSOLA SANWO-OLU EXECUTIVE GOVERNOR, LAGOS STATE

r. Babajide Olusola Sanwo-Olu was elected the 15th Governor of Lagos State on the platform of the All Progressives Congress (APC). He was declared winner of the March 9, 2019, gubernatorial elections by the Independent Electoral Commission (INEC) on Sunday, March 10, 2019, after defeating 44 other

contestants representing various political parties in the election.

A product of resounding victory, Mr. Sanwo-Olu polled 75.6% of the total valid votes cast in the election. His victory at the election is a solid endorsement of his leadership aptitude and the All Progressives Congress (APC) politics of development and inclusiveness in Lagos State. As an inspirational leader with a track-record of performance, his candidacy was welcomed by Lagosians as a continuation of a strong legacy of development in the State.

Mr. Sanwo-Olu, who was born on June 25, 1965, in Lagos State, is a reliable party man and astute Politician, reputed for his people-centred ideology.

His foray into public service started after decades of accomplishments in the private sector, especially the Nigerian banking sector, where he retired as a General Manager of one of the major commercial banks in Lagos.

This accomplished private sector expert, whose innovative mind quickly established him as an exemplary public sector reformer, started his early education at Government Demonstration School, Surulere and Ijebu-Ife Grammar School, Ogun State.

For his higher education, he proceeded to the University of Lagos for a Bachelor's degree in Surveying & Geo-Informatics, and a Master of Business Administration (MBA) in Management from the same University. Mr. Sanwo-Olu is also an alumnus of the prestigious Harvard Kennedy School of Government, London Business School and the Lagos Business School.





He is also a member of the Nigerian Institute of Directors (IOD), Chartered Institute of Personnel Management (CIPM), and Fellow of Nigeria Institute of Training and Development (NITAD).

In 2003, his eventful career opened to yet another colourful chapter with his appointment, first as Special Adviser to the then Deputy Governor, Mr. Femi Pedro, on Corporate Matters and later as Special Adviser to the then Executive Governor, His Excellency Bola Ahmed Tinubu, on Corporate Matters, in 2004.

Mr. Sanwo-Olu's entry became a reference point for professionalism and excellence in public service. At 39, he was appointed acting Commissioner for Economic Planning & Budget from 2004 to 2005, and became the substantive Commissioner for Commerce and Industry in 2007 following his exceptional performance.

His managerial imprint became noticeable at the Lagos State Ministry of Establishments, Training and Pensions in 2007 when he served as the Commissioner. During this period, he authored an executable Civil Service Framework designed around the Human Capital

Performance Index, which puts Lagos State civil servants amongst the highest and most regularly paid in the country.

A public officer with an impressive record of accomplishments, he was instrumental to the setting-up of Lagos State Pension Commission (LASPEC), a contributory pension scheme,



even ahead of the Federal Government of Nigeria.

Some of his notable contributions include setting-up and serving as the pioneer Chairman of the Lagos State Security Trust Fund Board, tracking and intelligent analysis of Internally Generated Revenue (IGR) by the various government agencies and parastatals,

including the Board of Internal Revenue (BIR), for executive consideration and policymaking; as well as preparation and publication of the Lagos State Economic Empowerment and Development Strategy (LASEEDS).

It is also to Sanwo-Olu's credit that the LAGBUS Asset Management Limited (LAGBUS) was established to ease the public transportation woes of Lagosians, complementing the Bus Rapid Transit (BRT) system in Lagos State. Mr. Sanwo-Olu also established the Control & Command Centre in Alausa, one of the LSSTF initiatives, which significantly improved the capacity of the security agencies to respond to distress calls in a swift and timely manner.

Mr. Sanwo-Olu was appointed the Chief Executive Officer (CEO) of the Lagos State Development and Property Corporation (LSDPC) in 2016, and in just 2 years, the visionary administrator had returned the hitherto struggling organisation to the path of efficiency and profitability. He also reengineered the organisation



to effectively tackle housing deficit in the State, which again validated his credentials as a resourceful leader and problem solver.

His valuable experience garnered from executive-level roles in the private and public sectors has not only distinguished him, but also made him a valuable resource to some notable organisations on whose boards he has served.

It is not unexpected that Mr. Sanwo-Olu's enterprising career in the private sector, his stellar record in public service, and selfless contributions to the society, would have attracted international recognitions and accolades at home. But as a man steeped in modesty, these awards and laurels serve as no more than an encouragement to keep him on the path of service to God and humanity.

As the 15th Executive Governor of Lagos State, Mr. Sanwo-Olu has spearheaded and re-engineered many socio-economic development programs in the State, under his people-focused development agenda, aptly named project T.H.E.M.E.S, representing Traffic Management and

Transportation; Health and Environment; Education and Technology; Making Lagos a 21st Century state; and Security and Governance.

At the core of his belief is the vision of a Greater Lagos, a Megacity and State in which no one is left behind; in which all residents can aspire to and enjoy a progressively better, more secure and more prosperous existence, regardless of age and gender, and of ethnic, religious or partisan affiliation.

Beyond Lagos State, Mr. Sanwo-Olu currently serves as Co-Chairman of the Progressive Governors Forum (PGF) Media and Communications Steering Committee, a member of the National Economic Council (NEC) Committee on Covid-19, and a member of the Management Board of the Niger Delta Power Holding Company. In 2020 he served as Chairman of the National Campaign Council for the ruling All **Progressives** Congress

Governorship Election, spearheading the successful re-election of the incumbent Governor.

A devout Christian and family-focused man whose marriage to Dr. Ibijoke Sanwo-Olu is blessed with lovely children, Mr. Sanwo-Olu, in addition to his love for public speaking, is a member of numerous prestigious clubs, which include Ikoyi Club 1938, the Island Club and Yoruba Tennis Club.





This prompted the birth of a 4 star Hotels and Suites in Ikeja, Lagos, Nigeria named Watercress International Hotels and Suites which he single-handedly built.

Since travel agency business goes with taxi and hotels, hence his desire to operate a taxi business in the United Kingdom, precisely in Milton Keynes, where he owns a 4 bedroom detached house without mortgage since 2008. He also owns a 30 rooms hotel in Alimosho Local Government of Lagos, since 2008.

In 2005, he established a Real Estate Company that buys and builds properties all over Nigeria.

He is a committed supporter of Universal Human Values and an advocate of Support For the Less Privileged.





He is a kinsman of the Okoro family of Etiti-Omuma, Uzodinma is a devout Catholic, and is married to Chioma Uzodinma with seven children.

He holds a Diploma in Maritime Management Technology, and Higher Diploma in the same field, from the Federal University of Technology Owerri. He also has a bachelor's degree in International Studies and Diplomacy from Washington University in St. Louis. Prior to his entry into politics, Uzodinma was a businessman

with vast business interests. He had the ceremonial title of Onwa-Netiri Oha of Omuma in Oru local government of Imo State.

#### **Early political career**

Hope Uzodinma began his political career during the Second Nigerian Republic, joining the ruling National Party of Nigeria (NPN), where in 1983, he became the Imo State youth leader. In the 1990s, with the aborted transition to the Third Nigerian Republic, Uzodinma featured prominently as a member of the United Nigeria Congress Party.

#### **Politics**

In 1999, after the return to democracy, Uzodinma joined the People's Democratic Party (PDP), where he served as a member of the party's National Caucus, National Executive Committee and on the Board of Trustees, at various times between 1999 to 2017. As a party boss in Imo State, Uzodinma was a close associate of the Governor Achike Udenwa until late 2002, when ahead of the April 2003 elections he decamped to the Alliance for Democracy (AD), becoming the party's candidate for the Imo State gubernatorial election. After losing the election to Udenwa, he returned to the PDP in February 2004. He later contested the PDP governorship primaries in December 2006, coming in second to Senator Ifeanyi Araraume. In 2011, after the incumbent Governor Ikedi Ohakim joined the PDP, Uzodinma endorsed him to run for a second-term as Governor of Imo State, favoring him over Rochas Okorocha who he later won.

In January 2011, Uzodinma won the PDP senatorial primary for the Imo West, gaining 2,147 votes, while the incumbent Senator Osita Izunaso came second with 891 votes. Uzodinma was later disqualified by a federal high court judgment as he had not been cleared by the PDP electoral panel led by Nwafor-Orizu. In March 2011,



a court of appeal issued a stay of execution while the case was being decided, leaving Uzodinma free to campaign. On 5 April 2011 the Court of Appeal upheld the federal high court judgement, Uzodinma later appealed this decision at the Supreme Court. In the April 2011 elections, Uzodinma received 85,042 votes, ahead of former Governor Achike **Udenwa of the Action Congress** of Nigeria (ACN) with 64,228 votes and Rajis Okpalan Benedicta of the All Progressives Grand Alliance with 57,110 votes. In May 2011, the Supreme Court overturned the earlier decisions and declared that Uzodinma was the valid candidate and therefore had been elected.

#### **Senator**

On 29 May 2011, Uzodinma was sworn-in as a Senator of the Federal Republic of Nigeria, representing Imo State (West Senatorial District). He was reelected for a second term in the Senate during the 2015 election. In 2018, he left the Peoples Democratic Party and joined the ruling All Progressive Congress (APC) in order to contest for Governor of Imo State in the 2019 general elections.

Governor of Imo State In March

2019, the Independent National Electoral Commission sitting in Imo announced the governorship election results of Imo State: Emeka Ihedioha of the PDP who won with 273,404 votes. Uche Nwosu of Action Alliance with 190,364 votes, Ifeanyi Ararume of the All Progressives Grand Alliance with 114,676 votes; and Uzodinma in fourth place with 96,458 votes. Uzodinma later challenged the victory of Ihedioha up to the Supreme Court. On 14 January 2020, the Supreme Court declared Uzodinma, the duly elected Governor of Imo State. The court held that results from 388. polling units were wrongly excluded from votes ascribed to Uzodinma and the APC in Imo adding that the first appellant Uzodinma holds the majority of lawful votes cast.

On 15 January 2020, he and Placid Njoku were sworn-in as the Governor of Imo State and Deputy Governor of Imo State respectively In his inaugural address, he ordered the states accountant general to provide a comprehensive financial status for the state from May 2010 to January 2020, he also ordered the permanent secretaries of all ministries in the state to forward the status of all contracts

awarded, whilst halting the paying for all ongoing contracts.

On 31 May 2023, Uzodimma emerged as chairman of the Progressive Governors Forum, the umbrella body of governors of the ruling All Progressives Congress (APC), replacing Abubakar Atiku Bagudu, the former governor of Kebbi State with the governor of Kaduna State, Uba Sani as the vice chairman.[18]

In the buildup to his re-election, Uzodinma on 13 August 2023, picked a new running mate, Chinyere Ihuoma Ekomaru for the 2023 Imo State governorship election.

He was sworn in for a 2nd term in office on the 15th of January 2024.





## Citation of Governor Mai Mala Buni Executive Governor, Yobe State

is Excellency, Hon. Mai Mala Buni Chiroman Gujba CON was born on 19th November 1967 in Gujba Local Government area of the state.

He received his early education at Buni-Gari Central Primary School and Government Secondary School, Goniri between 1973 and 1985. Over the course of the next several years, Governor Buni received part-time Islamic education. In 2010, he enrolled into Espan Formation University, Benin and bagged a BSc degree in International Relations in 2014.

The governor also holds a Master of Arts Degree in International Relations from Leeds Beckett University, Headingley Campus, Leeds, United Kingdom.

Before he became governor of Yobe State in May 2019, Hon. Mai Mala Buni has had a stellar political career both at the state and national levels.

He was Senior Special Assistant to Yobe State governor on Inter-Party Affairs between 2009 and 2011. Following the 2011 general elections, Hon. Mai Mala Buni was appointed Special Adviser to the governor on Political Affairs, a position he held until 2013 when he became Protem Secretary of the All-Progressives Congress (APC) in Yobe State.

In 2014, Hon. Mai Mala Buni became the State Chairman of the APC. A few months later, he became the party's National Secretary. As national secretary, Hon. Buni played an active and commendable role in wresting power away from the then ruling PDP and installing President Muhammadu Buhari of the APC as President of the Federal Republic of Nigeria.

Hon. Mai Mala Buni won a second term as national secretary of the APC in 2018 and in early 2019, he became



the governorship candidate of the party in Yobe State and went ahead to win the election in April 2019.

Governor Mai Mala Buni's political profile also included being the Speaker of Gujba Local Government Legislative Council in 1991. He was Chairman of Advanced Congress of Democrats (ACD), a political party in 2006 and between 2006 and 2010, he was the Yobe State Chairman of the Action Congress (AC).

Governor Buni attended many conferences and conventions and was chair and member of different ad hoc committees.

He has won many awards, including an Award of Excellence by the Coalition of Women in Politics in Yobe State in 2018. In the same year, Hon. Mai Mala Buni was also appointed chairman of the Nigeria Shippers' Council.

Governor Buni's political career went hand-in-hand with a successful career in business which saw him lead more than ten different companies and start-ups.

Since becoming governor in May 2019, Governor Buni has pushed the pendulum further with a renewed sense of urgency to develop the state.

### **Enhancing Legislative Accountability**

in Nigeria: A Call for Transparent

**Voting Practices** 

In any thriving democracy all over the world, legislative processes should reflect transparency, accountability and public trust.

One crucial aspect of this is how votes on laws are conducted and recorded.

A recent comparison of voting practices in the UK and Nigeria highlights a stark contrast, underlining the need for Nigeria to adopt more transparent mechanisms.

For instance, the UK's Model of Legislative Transparency is something of note.

In the UK Parliament, critical bills undergo recorded votes, a process that ensures full accountability.

For instance, the Terminally- III Adults (End of Life) Bill, which proposes allowing terminally ill adults with less than six months to live the choice of assisted dying, passed to the next stage by a majority of 55 votes.

The voting record is publicly available, allowing citizens to see how their Members of Parliament (MPs) voted.

This approach fosters a system where lawmakers are directly accountable to their constituents, and public trust is bolstered through transparency.

Nigeria's Predominantly Voice-Based Voting. Nigeria's Senate recently passed the Tax Reform Bill 2024 to the next stage as well, a landmark piece of legislation aimed at modernizing the tax system.

However, the vote was conducted through a voice vote, where senators shouted "Aye" or "Nay," and the presiding officer determined the outcome based on the loudest group.

While this method is expedient, it lacks the transparency that recorded



votes offer. This absence of individual accountability in the voting process diminishes citizens' ability to evaluate their representatives' performance and undermines trust in the legislative process.

A good example of this is when there is a Point of Order and the Case for Recorded Votes Nigeria's Senate Standing Orders provide lawmakers with tools to address this issue. Legislators can invoke a Point of Order to





request a recorded vote, particularly, on contentious or impactful bills.

This ensures that every vote is documented, offering the electorate a clear view of where their representatives stand on key issues. However, such requests often require the presiding officer's approval or the backing of a significant number of senators.

As far as democracy is concerned, there are Benefits of Recorded Votes for Nigeria. These include:

Adopting recorded votes as a standard practice would bring multiple advantages, enhanced Accountability. Lawmakers would be answerable to their constituents for their decisions.It strengthens Public Trust and transparency in legislative decisions and fosters greater confidence in

governance.

It also reflects positive alignment with Global Standards.

Many democracies, including the UK, prioritize recorded votes, setting an example Nigeria could follow.

It also increases Civic Engagement. When citizens can track their representatives' positions, they are more likely to engage in the political process.

In view of the benefits, there are Challenges and the Path Forward.

The primary challenge in implementing recorded votes lies in resistance from lawmakers who may prefer the ambiguity of voice votes. However, civil society, media, and citizens can advocate for

reforms that make recorded voting a norm, especially on bills with significant socio-economic or ethical implications.

Nigeria's democratic growth requires a commitment to transparency and accountability in legislative practices. Recorded votes are

not just a procedural improvement but a fundamental step toward strengthening democracy. Lawmakers, civil society, and citizens alike should champion this cause, ensuring that Nigeria's legislative processes reflect the highest standards of integrity and public trust.

By institutionalizing recorded votes, Nigeria can bridge the gap between its legislative practices and those of global democracies, fostering a political culture rooted in openness and accountability.
